

"Program Notes"

Our Guest speaker was arranged and introduced by *Chairman Bobby George. Dale Washburn* is the *Georgia House Representative for District '141'* serving north Bibb and south Monroe Counties since he was elected in 2018. Born and raised in Macon, *Dale* is a husband to Donna for "42" years, father, grandfather, and a businessman. *Dale* has been in the real estate business for "42" years and he founded *Washburn & Associates*, which specializes in real estate brokerage and consulting, and *The Dale Washburn School of Real Estate*; Dale has been teaching real estate for "20" years. *Dale* is also the author of two real estate licensing textbooks and numerous continuing education courses. *Dale* strives to combine knowledge, experience, work ethic, and integrity in dealing with whatever arises. Dale began his remarks with a short presentation on the state of the real estate business during the past year. He shared that the business is going through an "unbelievable time". It is a "sellers market" with real estate selling for inflated prices. Giving an example, he shared - "a young couple wanted to sell their older home that had been renovated. We valued the home at \$179,000 anticipating a sale at \$170,000. The couple would not list the home for less than \$200,000. We acquiesced and listed it at the seller's price, thinking no way it is going to sell that high. It sold in two days for \$208,000." The market is unbelievable. It is artificially inflated and in a year or two the properties sold today will be worth a lot less.


Dale then moved on to his remarks around his service as Georgia House State Representative for District '141'. In his remarks, **Dale** shared his foundational structure for his political service - 1} it is a great honor to serve the people in his District as well as fellow Georgians; 2} in considering all legislation "what is best for families and best for Georgia business" should always be the first priority; 3} that less governmental regulation rather than more is always better; 4}public officials must diligently guard against allowing the ever increasing tax burden to continue to rise; and 5} his Christian beliefs lead him to believe that "God's plan for society is a civil, orderly one, job oriented, and for the individual to do the best job possible – resulting in a better living environment for all Georgians – "the rising tide floats all boats". Everyone impacts their life and lives of others.

Dale shared that in the political arena, the "sides" will always have differing beliefs in issues. In a lot of issues, the "sides" can meet on common ground and agree to the extent that the issues can be resolved to the betterment of the people of Georgia. On some issues, the "sides" will never meet. Giving an example, **Dale** shared - "on the issue of abortion, I believe that life begins at conception which means I can not vote for abortion. There is a lady that sits next to me in the House and she shed tears when I voiced my belief and voted against abortion. She would not speak to me and turn her back to me for several months after the abortion vote. She will not be "swayed" on the issue — nor will I."

Dale shared that he was instrumental in writing and proposing "4" House Bills – "2" of which made it through the House, Senate, and was signed into being by the Governor. The most contentious Bill being the *Voting Rights Bill*. **Dale** shared that the Bill was not voter suppression – under the *Voting Rights Bill*, the voter has "17" days in which to vote (days of early voting built into the Bill) the voter can vote in person or by mail (has to provide proof of who you are in the way of Georgia Driver's License, or the last "4" digits of the Social Security number, or a photostatic copy of a utility bill). Prior to the Pandemic, there were no Voting Drop Boxes and there will be less drop boxes as we move forward (however, there are millions of drop boxes in Georgia – they are called mail boxes).

Dale's other approved legislative Bill was to allow for the voters to be able to decide on the OPLOST One Cent Sales tax. The OPLOST, if passed by the voters in Bibb when it comes up on the ballot, will reduce property taxes by "5" mills the first year and "7" mills the second year (on a \$200,000 home, the tax savings could amount to \$400 the first year).
